Description of Communications

The following is a set of August 8-13, 2021 communications from Elton and Janice Gallegly (the "Galleglys") to James Lacey, a local VIP and Gallegly supporter. Lacey has no known ties to CLU and has never met Varlotta. This particular set of emails shows that the Galleglys were working with allies before even they filed the case in the court system. Their early outreach to the media allowed them to create and control the public narrative before CLU even knew a lawsuit was forthcoming. As documents will show, much the narrative the Galleglys created was inaccurate, partial, and distorted.

From the very beginning, the Galleglys admit (see yellow highlights) that the aim of the public campaign is to keep the pressure on CLU and to control what is being share with the media. Such statements explain how and why the Galleglys had many victories in the court of public opinion.

All of these communications and attachments were produced during Phase One of Gallegly v. CLU discovery process. Since they are all part of the official court record, they are open to public review and scrutiny.
