Dear Attorney General Bonta,

I am writing you to request that your office commence an investigation into Cal Lutheran University's handling of nearly \$1 million raised by donors for The Elton and Janice Gallegly Center for Public Service and Civic Engagement at California Lutheran University.

I had the honor to represent Ventura County while serving in the United States Congress from 1987 to 2013. In 2012, before retiring from Congress, I reached a written agreement with CaJ Lutheran University to establish the Gallegly Center, The Center was constructed to be a meeting place for public service and civic engagement and contain an exact replica of my Washington, D,C Congressional office. Also, included in the agreement was digitally archiving my 26 years of papers and documents, a distinguished speakers series, and the Gallegly fellowship program, My wife and I led the fundraising effort for the Center and raised over \$1 million from over a hundred of donors.

While some funds have been expended over the past several years, I and others have be-tome concerned over CalLutheran's stewardship of the money raised, I communicated those concerns on April 6, 2021 in a Zoom can with current Cal Lutheran President Lori Varlotta and several others, including my attorney and Cal Lutheran's attorney. In that call, President Varlotta committed to conducting a "forensic audit" of the money that had been raised for the Gallegly Center. On June 3, 2021, the attorney for Cal Lutheran emailed my attorney and said the University would not conduct the forensic audit promised.

Cal Lutheran's refusal to account for the funds raised, and their decision to cancel a forensic audit to which the school President had agreed, is very concerning. I persuaded hundreds of people to give money to this project and feel I have an obligation to account for their donations.

In light of the refusal by Cal Lutheran to provide au accounting for the funds raised, 1 believe an outside body with legal authority, such as your office, must investigate Cal Lutheran's handling of the money raised and spent for possible violations of Penal Code sections 503-513,

I know I sent you a lot of material - but thought you may want to see how we got from point A to point B. The most important legal documents for you to read are the ones dated 6-18 from our attorney David Laufer and their one page response on 6-28 and CLU's attorney Baker transmittal dated July 23. I also attached a copy of the lawsuit you requested.

One of your best arguments is that the Reagan-Gallegly fellowship was to be in perpetuity and CLU is only committing to 3 years. The first two years for which they have the funds from money we raised and the third year where they claim to reallocate funds to cover. After that the fellowship will be contingent on CLU's ability to raise the funds. Well, CLU has depended on us to raise all the funds up to now. Saying the VP's office of Advancement will aggressively fund raise is a joke.

CLU was to be entirely responsible for the archiving of the documents. But in order to get started on the archiving, CLU said we had to raise \$150,000. By not digitizing the materials makes them only available to someone who can physically make it to the CLU Library. I hope that President Varlotta would reconsider her decisions. **Editor's Note:** On November 15, former Congressman Gallegly filed a 66-page lawsuit in Ventura County Superior Court for breach of contract for Cal Lutheran failing to fully establish the Elton and Janice Gallegly Center For Public Service and Civic Engagement. The former Congressman and his wife raised more than \$1 million for the center. Congressman Gallegly represented parts of Ventura County in the House of Representatives from 1987 through 2012.

California Lutheran University has removed the replica Washington, D.C., office of former Rep. Elton Gallegly in a dispute he has taken to court.

The school had long said it planned to take down the office, which had been on display for the past 3½ years, to make room for Gallegly's archives.

"We are pleased that the arranged, preserved, and cataloged collection will soon be made available to scholars and students to pursue the type of research activities the center was meant to fuel," university spokeswoman Karin Grennan said Tuesday.

She said items from the office will be stored at the school but will not be available for viewing.

Gallegly, a Simi Valley Republican who served in Congress from 1987 through 2013, said he didn't know exactly when the replica office was removed. He said he believed it was in the last seven to 10 days

"I'm very disappointed in the lack of professionalism and fairness of what she (Lori Varlotta, the university's president) has done, while litigation is pending," Gallegly said Tuesday. "I would have thought she would at least have the courtesy of letting the judge make the decision."

The office was the centerpiece of the Gallegly Center for Public Service and Civic Engagement, named after the former congressman and his wife, Janice, in the Pearson Library on the school's Thousand Oaks campus.

But Varlotta said it was never much of a draw.

Gallegly sued the university in November in Ventura County Superior Court, alleging the school breached its contract to fully establish his namesake center.

The lawsuit also argues the university violated an obligation to maintain the replica office.

Varlotta, however, said the office was displayed at the school's discretion. She and the university's former president, Chris Kimball, are also named as defendants in the suit.

The university asked the court in December to dismiss the lawsuit, arguing the school has met its obligations for the Gallegly Center, which opened in May 2018.

# Excerpt 1 comes From E. Gallegly's deposition on October 13, 2022 (pp 159-161).

Q. [t] the question is: "Identify every donation you made to the Defendant Cal Lutheran University from moneys not held by the committee, Gallegly for Congress."

So ostensibly this would include donations that you made or Ms. Gallegly made. As I read your response, starting at line 25 and continuing to page 12, to be nice to you, though. But it -- he doesn't answer your question.

#### BY MR. BURRIS:

Q. Yeah. I will smile and nod and not answer and go to the next question. The response to the supplemental - the supplemental special interrogatories. And I -- I didn't mark the exhibit on my piece of paper, but I think it's Exhibit 6.

MR. SLYNGSTAD: That's -- that's part of it right there. THE WITNESS: Uh-huh. Okay.

Maybe it's in the next page. Bottom 8. it says that you provided a desk chair -- or I'm sorry -- a desk, chair, pictures, plaques, and other office memorabilia subject to a loan.

- A. Uh-huh.
- **Q.** That you purchased -- you personally purchased your desk from the GSA. That you donated the papers and the archival legislative collection to Cal Lutheran in 2017. And that you hosted numerous dinners and meetings at your home and provided food and drink to prospective donors. I don't want to rush through it, so take --
- A. Yeah, there's a list of the names on there.
- Q. Uh-huh.
- A. Those are all accurate. What's your question?
- Q. So my question is: When we looked at the request for admissions and said admit that it was --that all the money came from the committee, Gallegly for Congress, you -- you said denied. But when we look at this answer, I'm looking for some money that went from your hands to Cal Lutheran's hands, and I don't see any referenced.
- A. I don't know the answer to that question. I know we brought in a

lot of money. I don't know whether it's mine or -- I know I brought i I know I brought in a lot of checks from people that we went to.

During Ms. Gallegly's sworn deposition, she, too, is asked about the personal donations that she and/or her husband made to California Lutheran or the Gallegly Center. Here is a response she provides on page 207 of her testimony.

Well, the -- the Gallegly for Congress funds fall under FEC, and it's a charitable organization; but it's the Gallegly for Congress that gave that money.

When we had dinners in our home and paid for them, lots of times it was our money.
